MINUTES

There were 48 attendees from 16 communities.

Program: Environmental Progress in the New Era with speakers J.C. Kibbey of Union of Concerned Scientists and Lisa Albrecht, Illinois Solar Energy Association re Clean Jobs Bill & Renewable Energy

Beth Drucker

- Asked CONSEG members and groups to contribute towards \$1,000 goal for CONSEG website. This would enable us to communicate between meetings more effectively. If you have not yet contributed (LINK TO GGW)
- Trying to arrange screenings of "Before the Flood" all over northern suburbs (both public and private)

Kim Stone

- A ban on coal/tar sealants was passed in Highland Park
- We must refocus this year on larger impact items like climate change.

JC Kibbey/ Union of Concerned Scientists, Midwest Outreach and Policy Advocate, Union of Concerned Scientists

- UCS began with the mission of combatting nuclear armament in the late 1960's, yet now their efforts have become focused on climate change.
- Facts are not enough to change closed minds.
- Financial incentives, industries, and economies that are predicated on the non-existence of climate change are significant role players in convincing individuals that the threats which the issue poses are not real.
- Need more incentives for people currently are in denial to believe in climate change.
- Two deadly heat waves will happen in Chicago every summer (similar to the kind that killed 700 people in 1995)

- 200,000 people die annually in the U.S. from air pollution
- Technical challenge of implementing renewable energy → Necessitates the political will to commit to solving these problems
- Community is more convincing than outer political/scientific motivators
- UCS is concerned about the nominations of Scott Pruitt and Rex Tillerson. Contact Senators Dick Durbin and Tammy Duckworth to ask that they vote against both:

- Call any family/friends/colleagues in Ohio, Florida, or Maine to ask them to call their senators to oppose Pruitt and Tillerson.
- Ask news stations to address weather/climate reports with the severity they deserve.

Lisa Albrecht

- The Clean Jobs/Energy Bill passed, including wind/solar energy legislation as well as regulation on ComEd and Exelon operations. The bill also allows the state to invest more in renewable/clean energy.
- Gov. Rauner hasn't given out solar rebates since 2014, as those would be a part of the Illinois budget → in past four years, Illinois has installed no new wind power.
- Wind energy is the first project to be initiated with the Clean Jobs/Energy bill's implementation.
- The bill gives more stability to Renewable energy certificates (RECs), and the payment process for homeowners installing renewables.
- Homeowners/citizens can now be eligible for state rebates on green technologies year-round.
- Authorized Illinois Power Agency to modify incentives to manage supply and demand.
- State rebate program will offer better discounts on solar power earlier in the year to incentivize residents who want solar REC's ASAP.
- Target for community solar: 1,500 kwh by 2020

Goal- Have solar eventually become cheaper than fossil fuels.

- Community solar = ~25% residential (10 kwh). Some homes are not appropriate for solar, so community solar can provide access. Developers use vacant land to implement solar arrays, and individuals can subscribe/purchase energy generated from these arrays.
- New government program for low-income residents to be trained in solar technologies/subsidize solar power for their homes.

• 5% threshold between net metering and solar kwh. REC's \$250 rebate per every kwh produced. (Government/ municipal solar will have different restrictions on rebates than community solar)

-Anthony Starr- head of Illinois Power Agency, in charge of power procurement for the entire state.

Oak Park Pesticide Resolution

We urge you and your group to join Oak Park in working to reform our state's preemption with regard to pesticide use. (See Oak Park's resolution here:

http:bit.ly/OakParkPreemption) Currently, 43 states restrict local governments' authority to regulate pesticide use more stringently than state law, including Illinois. This means localities can only address pesticide use on public property, and cannot restrict toxic pesticides on private property. Oak Park's resolution also has the support of the Illinois Environmental Council, Midwest Pesticide Action Center and State Senator Don Harmon. Once a group is willing to take on the task of presenting their concerns to their village board, i.e. asking them to vote on this resolution (which is directed to the General Assembly, asking them to amend the Pesticide Act which disallows home rule for pesticide regulation), Senator Harmon is willing to contact the Senator who represents their district and lend his support.

We really need a broad representation of communities to support these Senators because they will receive a lot of pushback from chemical, lawn care and golf industries.
