01:03:52 Kim Moldofsky / GG Morton Grove: It is illegal in many communities. Would love to suggest new language to mine to make it legal. Currently, fruit and vegetable scraps are defined as garbage in our code.

01:05:24 Edith Makra, Metropolitan Mayors Caucus: Thanks, Seema. We have a full presentation of priority climate strategies in the PCAP. See the waste sector of p11 https://mayorscaucus.org/wp-content/uploads/2024/03/Priority-GHG-Reduction-Strategies-3-4-24.pdf . The priority strategies include reducing waste and recycling generally, so plastics are included. If you look at the slide Nora showed about the source of GHG emissions, you'll see that buildings, industry and transportation are the most significant sources of emissions. Emissions from plastic production or plastic waste are not significant. But our greatest opportunities for emissions reduction are in the building, industrial, and transportation sectors.

01:05:28 Merleanne Rampale:One of our ICAW Adventures was a bin building demo with a tour of his garden and composting processes. So many wonderful learning opportunities and experiences all over Illinois, especially in the northern Illinois region.

01:07:57 Edith Makra, Metropolitan Mayors Caucus: @Cindy Grau -Go Green Park Ridge It is possible, but we didn't do a lot of outreach for our landscape equipment electrification grant application. We will if we get the grant!

01:09:16 Michael Garfield-Buffalo Grove: Waste Management in Buffalo Grove just started plant food waste collection from April to December along with lawn waste.

01:10:06 Jeff Weiss Buffalo Grove Environmental Action Team: Waste Management recently started picking up food scraps in Buffalo Grove (no meat) during the landscape waste season (April-December)

01:12:02 Kim Stone, Highland Park: Replying to "Does LRS compost the..." Yes.

01:12:18 Wendy Greenhouse, Oak Park Climate Action Network: In Oak Park, residents of buildings with 5+ units are not served by the muni waste contract but must

contract with a service such as WasteNot or take their kitchen waste to one of 5 public drop sites. Renters and condo owners in other communities could be similarly excluded by muni compost programs.

01:13:06 Deb Singleton, Deerfield: Has any research been done on the infiltration of plastic micropellets from composting bins into the compost?

O1:13:22 Jennifer Nelson: This is updated as we receive updates from people. We do a review and check of all of them each year.

01:13:41 Wendy Greenhouse, Oak Park Climate Action Network: Keeping your compost in your freezer can be a helpful option for those who have to haul their own to a drop site. i.e. your kitchen waste! which will become compost.

01:14:33 Deb Singleton, Deerfield: Also, what are the metrics of the GHGs produced by collection programs (esp waste trucks) vs those saved by reducing methane production by landlfills?

01:15:00 Jennifer Nelson: Replying to "Does LRS compost the..."

LRS is a hauler - they haul waste, recycling and organics (yard waste and sometimes food scraps). The composting happens at a commercial compost processor.

01:15:31 Michael Garfield-Buffalo Grove: Collective Resource Compost Coop 5 gallon buckets are air tight and can stay in your kitchen for the two weeks between their swap out pick up. No smell and a new container every two weeks.

01:15:39 Wendy Greenhouse, Oak Park Climate Action Network: LRS is the contractor for my 28-unit condo building. They will not pick up organic waste for us.

01:16:30 Merleanne Rampale:That year-round with no opt-in is the way to go!

01:16:45 Jennifer Nelson: Replying to "Does LRS compost the..."

Whether or not food scraps are included depends on the contract your municipality or building have with the hauler.

01:17:05 Wendy Greenhouse, Oak Park Climate Action Network: In Oak Park, the compostable pickup service for residents on the muni contract is an opt-in program. Some of us are fighting to make it an opt-out. The subscription rate is lower than it should be.

01:21:00 Jeff Weiss Buffalo Grove Environmental Action Team: SWALCO, do you net out emissions from vehicles hauling food scraps when you calculate benefits of composting?

01:22:03 Kim Stone, Highland Park: Replying to "SWALCO, do you net o..." If the food scraps were instead in the trash, they would be trucked to the landfill instead, so the emissions for the transportation are essentially a wash.

01:22:08 Joe Haughney GGDeerfield: The city of Seattle has a long running program to separate food waste from the waste stream. this includes fines to residents who do not participate.

Yes Joe and even apartment complexes/multi family dwellings have containers for organics -- it's just a way of life there and children grow up with this as a natural process.

01:27:11 Edith Makra, Metropolitan Mayors Caucus: FYI, the GHG inventory for the Chicago MSA showed waste, inclusive of food waste was the lowest source of emissions in our region. Figure 3. Greenhouse gas emissions in the Chicago MSA region by subsector, listed in order of greatest to least share of the total inventory, 2020 Source: CMAP, 2024.

The ride along programs have some differences from what WasteNot offers with our bucket swap residential service model, so our services are more expensive, but not significantly more so

I will say there was a little freebie giveaway if they "pledged" to participate, so that may have helped too. Ud be happy to share. Pretty simple little kit but seems to be effective.

01:48:03 Candice Dalrymple (Highland Park Go Green): Could one of our experts comment on compostable liner bags? Cleaning composting bins and disposing of the water required can be problematic for some residents.

01:51:54 Merleanne Rampale: I'm going to share my personal thoughts on liner bags. Ideal is no liners. Especially for kitchen counter top pails -- we rinse out our coffee mugs, we can rinse out our kitchen pails. I do not line my home organics cart either, as I feel like

that although it's "compostable" it's still a single use item and I consider all of the time, energy, water and other resources that go in to making that liner. Forego them if you can. However, I will say if the only way we can get schools or home owners, businesses to compost commercially is to use liners then I absolutely support using liners if that's the only way.

01:52:47 Kim Stone, Highland Park: I try to reuse greasy paper bags if I need to bag my kitchen compost.

01:53:01 Seema Keshav: Not the expert but according to this 5 gyres report, further research is required into the toxicity of bioplastics (as it can be picked up in the soil). They however reference biobag as a liner that seems to be free of toxic chemicals (page 79) Better+Alternatives+3.pdf (squarespace.com)
